



These Terms and Conditions (“Terms”) govern this promotion offered by PayPoint Network Limited (“PayPoint”) to retailers who:

- a. registered their interest to become a PayPoint Park Super Agent via <https://paypoint.com/parksavings> during the period commencing on the 26 April 2023 and ending on the 31 May 2023; and
- b. register their interest to become a PayPoint Park Super Agent via <https://paypoint.com/parksavings> online during the period commencing on the 01 June 2023 and ending on the 30 June 2023 together (“Promotion Period”).

These Terms are considered as “other documentation” pursuant to Section 1 Clause A.2.5(f) of your General Retailer Agreement. Any capitalised terms used here and not defined herein are as set out in the General Retailer Agreement.

Please read the following Terms carefully and keep a copy for your information.

1. Eligibility

1.1 In order to be an eligible participant for the PayPoint Park Super Agent Prize Draw 2023, You must meet the following criteria:

- (a) You must be an existing PayPoint Agent in good standing with PayPoint who has registered their details to become a PayPoint Park Super Agent; or
- (b) You must have signed a General Retailer Agreement with PayPoint and become an accredited PayPoint Agent on or before the 31st of August 2023; and

1.2 The criteria in paragraph 1.1. are referred to as the Eligibility Criteria and Retailers who meet the Eligibility Criteria shall be “Eligible Participants”.

1.3 For the avoidance of doubt, any PayPoint Agent or Authorised Site that has left the PayPoint retail network in the 6-month period immediately preceding the Promotion Period shall be excluded from participating in the PayPoint Park Super Agent Prize Draw. This shall include any Authorised Sites or PayPoint Agents that have undergone a change of ownership or legal status change during the 6-month period.

2. Promotion

3. Participation

 - (b) PayPoint Agent number, if an existing PayPoint Agent
 - (c) Authorised Site fascia
 - (d) Authorised Site address
 - (e) Authorised Site number, if an existing PayPoint Agent.

The email should have the following in the subject line: "PayPoint Park Super Agent Prize Draw Opt Out" and the email must include your confirmation that you wish to be opted out of PayPoint Park Super Agent Draw prize draw. All of the information that is needed to submit your opt out can be found on your Confirmation Form.

- 3.2 By taking part in the PayPoint Park Super Agent Prize Draw, you agree to be bound by these Terms and confirm that you are not restricted from complying with these Terms in any way.

4. Prize Draw

- 4.4 PayPoint may request further information or documentation, as may reasonably be required, in order to assess your Entry.
- 4.5 If a winning Entry is deemed not to comply with these Terms and/or any other conditions of entry, the Entry will be discarded and a new winner of the prize will be determined at random using the same method as detailed above.
